COMMAND POLICY MEMORANDUM 23-1

SUBJECT: United States Army Japan (USARJ) Assignment of Units to Special and Summary Court-Martial Jurisdictions

- 1. This memorandum rescinds and replaces Command Policy Memorandum 23-1, dated 17 March 2023.
- 2. Special Court-Martial Convening Authority (SPCMCA). Pursuant to Article 23 of the Uniform Code of Military Justice, the following are designated as SPCMCAs within the USARJ area of jurisdiction and are authorized to exercise SPCMCA jurisdiction over all units assigned under their command (including direct reporting units located in Guam) and separate units as aligned in accordance with paragraph 3, below:
