COMMAND POLICY MEMORANDUM 12-15

SUBJECT: U.S. Army on Okinawa Off-Limits Locations

1. References:

- a. AR 190-24, Armed Forces Disciplinary Control Boards and Off-Installation Liaison and Operations, 27 July 2006.
- III Marine Expeditionary Force/Marine Corps Installations Pacific Bulletin 5800, 6 January 2016.
- 2. Applicability. This policy applies to all SOFA-status personnel assigned, attached, or otherwise present for duty with the U.S. Army on Okinawa and their SOFA-status Family members.
- 3. Policy. After following the procedures of the referenced joint regulation, the Okinawa Armed Forces Disciplinary Control Board has determined that the activities at these establishments on Okinawa constitute a threat to the health, safety, and welfare of SOFA-status personnel. As the General Court-Martial Convening Authority for the U.S. Army on Okinawa, I am directing that the following 17 establishments, to include the physical location, to be "off-limits," to all U.S. Army-sponsored, SOFA-status personnel:
 - a. Ground Tobacco Shop: 2F, 1-5-9 Mihama; Chaton-Cho
 - b. Tokyo Syoten Bookstore; Highway 23 at 820-6 Kamisedo, Chatan-Cho
 - c. Takahara Hotel (also known as the Royal Hotel; above the ruins of the Nakagusuku Castle Park, near Camp Foster
 - d. Stoners Den; 2-17-1 Makishi, Naha-Shi
 - e. Yoshihara Red-Light District (establishments with storefronts that face Highways 329 or 330 are not off limits)
 - f. Jah Reggae Shop; 1-6-20 Chuo, Okinawa-Shi
 - g. Bon Bon Dou; 1-9-8 Uechi, Okinawa-Shi

- h. Bar Sakura; 1-10-15 Chuo, Okinawa-Shi
- i. High Times; 1-6-2 Chou, Okinawa-Shi
- j. Soft Cream (and distribution service, "Lequio Herb")' 1-15-8 Okinawa-Shi
- k. Color; Takahara Building, 2-6-34 Makishi, Naha-Shi
- 1. Green House; 1-3-1 Uechi, Okinawa-Shi
- m. Heaven's Smell (formerly, Samurai King); 1-8-1 Chuo, Okinawa-Shi
- n. Herb Shop Garu-Garu; 2-7-2 Wakasa, Naha-Shi
- o. OM's Herb Shop; 2F, 3-7-12 Yafuso, Urasoe-Shi
- p. Yasu Ichi Bookstore; 2-1-10 Chatan-Cho
- q. Fantasy Space Okinawa; 2 Chrome 17-46 Makishi, Naha-Shi
- 4. This policy memorandum is punitive in nature and violations will be considered for discipline under Articles 90 and 92 of the Uniform Code of Military Justice for Soldiers. The full range of regulatory and administrative sanctions will be considered for Soldiers, Civilians, Family members, and Contractors.
