COMMAND POLICY MEMORANDUM 24-13

SUBJECT: United States Army Japan (USARJ) Supplement to United States Forces Japan (USFJ) Liberty Order

1. Reference. United States Forces Japan (USFJ) Liberty Order for All U.S. Military Forces Located or Operating in Japan, dated 16 September 2024.

2. This order rescinds and replaces USARJ Command Policy Memorandum 24-13, USARJ Supplement to USFJ Liberty Order, dated 12 August 2024.

3. General Order. All personnel will read the referenced USFJ Liberty Order. The provisions of that order restated in paragraph 5 below are punitive. Soldiers who fail to comply with the punitive provisions are subject to discipline under Article 92 of the UCMJ as well as adverse administrative action authorized by applicable laws and regulations. Subordinate commanders are authorized to promulgate supplemental policies consistent with this memorandum.

4. Applicability. This order applies to all U.S. Army Soldiers located in Japan, including Army Reserve/National Guard personnel while in any status which subjects them to UCMJ jurisdiction. It applies to all Soldiers in a Temporary Duty (TDY), deployed, leave or pass status within Japan. This order is effective upon signature and will remain in effect until modified or rescinded, pending further assessment of operational environment in Japan.

5. Soldier Obligations.

a. All personnel 19 years of age or below including those who are in a TDY deployed, leave, or pass status in Japan, are subject to curfew between the hours of 0100 and 0500. During curfew hours, military members subject to curfew must be

(1) on a U.S. military installation;

(2) in a private, off-installation residence;

(3) in a place of lodging (hotel);

(4) transiting directly between an airport and a U.S. military installation, a private off-installation residence, or a place of temporary lodging (hotel); or

(5) in the performance of official duties (including duty-related travel).

b. The first commissioned officer exercising nonjudicial punishment authority may grant curfew exceptions, in writing when practicable, of limited duration on an individual, event-by-event basis for specific circumstances.

c. All personnel, regardless of age, are prohibited from off-installation public consumption of alcohol between 0100 and 0500 (on all days, including holidays). Public consumption of alcohol is any consumption of alcohol off a military installation, except when in an off-installation residence, quarters, or hotel room.

d. All personnel, regardless of age, are prohibited from being physically present in an off-installation drinking establishment between 0100 and 0500 (on all days, including holidays). A drinking establishment is defined as any business whose primary function is serving alcoholic beverages for consumption on the premises. A drinking establishment may serve food or have other forms of entertainment, but its main purpose is to serve alcoholic beverages. Drinking establishments may include, but are not limited to, bars, pubs, taverns, nightclubs, and izakayas.

e. All personnel are prohibited from going to "off-limits establishments" as determined by the Joint Armed Forces Disciplinary Control Board process, or other locations as determined by proper authority.
