
Claims - DD FORM 1840/1840-R

Two Step Process:

•MUST provide notice to the Transportation Service Provider (TSP) of damages or loss within **75 days**.

•File online claim at <u>www.move.mil</u> within 9 months of delivery for Full Replacement Value (FRV).

Claims Office can provide additional assistance.







- Japanese Motor Vehicle Laws
  - "<u>Professional Driver</u>"
  - "Professional Negligence"
  - "<u>Comparative Negligence</u>" ("Comparative Fault")
    Partial Negligence = Criminal Liability (Cycles, Bikes, Pedestrians)







- Legal Age is <u>20 Years Old</u>
- Implied Consent
  - Take BAT or Forfeit License
  - <u>No</u> On-Post Exception (same laws on & off post)

#### Japanese Driving Laws

- Japanese Law Blood Alcohol Content Limit = <u>.03%</u>
- Pretrial <u>Detention</u>
- <u>Fine & Prison</u> in Japan
- <u>Revocation</u> of SOFA license



- <u>Passenger</u> Liability riding with drunk driver
- Suspension & Revocation (New as of: 30 March 16)
  - 60 days suspension for .03.-.049 BAC
  - 6 months revocation for .05-.079 BAC
  - 12 months revocation for .08 BAC and above





## **Prohibited Items**

- Firearms / ammunition
- brass knuckles
- slingshots
- BB guns
- pellet guns
- switchblade knives
- stilettos & daggers
- Knives with blades longer than 5.8cm (<2.3 inches)

Sexual Assault Laws

- Japan has primary jurisdiction in cases involving Japanese citizens as victims
- If you are a suspect in a crime and the Japanese decide not to prosecute, you can still be charged under the UCMJ (military members)
- Age of consent:
  - UCMJ 16 years old
  - Japan

Article 4 of the Child Welfare Law of Japan defines "child" as "anyone below 18 years of age. The consent age depends on the prefecture, however, the Japan adult age is considered to be at the age of 20.

### Military Justice - Other Issues

Family Member Misconduct

Penalties

- Community Service
- Fees
- Early Return of Dependents (ERD)
- Bar from post
- Do not contribute to the "<u>Black Market</u>" (e.g., sell PX items off base)
- Make sure your dependents are properly SOFA licensed to drive!
- Visitors must have a SOFA license to drive on post!
- <u>Be careful with off-base OTC medications</u>!
- If in doubt check with MEDDAC / MPs
- Example: "Bron" contains codeine a Schedule II narcotic under the U.S. Controlled Substance Act







Military Justice - Curfew

- Currently SGT (E5) and below: 0100-0500
- Off-installation public consumption of alcohol prohibited between 2400-0500
- Commanders can make some exceptions
- There are various other exceptions, so check with your command!
- Review the CG's Liberty Policy!







#### Individual Privileges – GET PRIOR APPROVAL

- Commercial Activities Restricted
  - May Teach English
  - Home Business or Off-Post Work <u>Requires</u> <u>Garrison Command Approval!</u>
  - Call Legal Assistance for Help
- Off-post employment cannot be:
  - In a bar or establishment that regularly sells alcohol.
