Note: Completion of Studies includes those applicants who are expected to graduate (at the end of the current school year or current semester) with a condition to present the certificate of completion of education. Failure to present completion of education upon at a specified period of time (a month) will be considered as failure to meet the requirements of the job.

Combination of Experience and Education:

For BWT 1-4 and above Experience and Education may be combined. Combinations of successfully completed post-high school education and experience may be used to meet total qualification requirements for the grade levels specified in the table, and may be computed by first determining the applicant's total qualifying experience as a percentage of the experience required for the grade level; then determining the applicant's education as a percentage of the education required for the grade level; and then adding the two percentages. The total percentages must equal at least 100 percent to qualify an applicant for that grade level. Only graduate education in excess of the amount required for the next lower grade level may be used to qualify applicants for positions at grades BWT 1-6 and BWT 1-7.

Note: Manual work experience may include unpaid manual work that demonstrates the applicant's ability to perform the duties of the position.

\*May require completion of specialized training or requirement to obtain an appropriate license.

Note: <u>Specialized Experience</u> is defined as experience in substantially the same line of work as the job to be filled, whether the experience was acquired at USFJ installation or in private industry. Candidates must show experience that has equipped them with the knowledge and skills necessary to successfully perform the duties of the position. General experience is defined as work that indicates ability to acquire the particular knowledge and skills needed to successfully perform the duties of the position. Candidates must show experience that has given them the qualifications to successfully perform the duties of the position.
