SUBJECT: Host Nation (HN) Employee Investigation Program

- 2. Records Management. All records created because of this policy will be managed in accordance with AR 25-400-2, Army Records Management Program and in accordance with reference 3, as applicable.
- 3. This policy applies to United States Army Japan (USARJ) staff offices, subordinate commands, assigned, attached, other units, and activities to include all activities and organizations operating within the USARJ area of responsibility and employing HN employees under the USARJ Executive Agent.
- 4. In continuous pursuit of excellence, fostering an environment that promotes both harmony and high productivity, and unwavering commitment with the Government of Japan to maintain integrity, accountability, and transparency on managing our HN employees, I have directed the creation of a formalized HN Investigation program. This initiative is designed to improve the workplace culture and environment while ensuring that every team member can thrive and contribute to our collective success.
- 5. Active support is crucial to the success of this program, thus, effective immediately, all Commanders and Directors of applicable units are to provide highly qualified HN employees to be trained and serve as certified investigators as a collateral duty in ongoing and future investigations. The numbers of HN employees provided will be directly commensurate to the population of HN employees within your units/activities.
