MEMORANDUM FOR RECORD

SUBJECT: United States Army Japan (USARJ) Assignment of Units to Special and Summary Court-Martial Jurisdictions

1. References.

2. This memorandum rescinds the prior version of this policy titled United States Army Japan Assignment of Units to Special and Summary Courts-Martial Jurisdictions, dated 12 March 2021.

3. Special Courts-Martial Convening Authority.

a. Pursuant to the Manual for Courts-Martial (2019 Edition), Article 23, and USARPAC Supplement Regulation 27-10, dated 19 January 2018, the following are designated as Special Court Martial Convening Authorities within USARJ area of jurisdiction:

- (1) Commander, United States Army Garrison – Japan.
- (2) Commander, 38th Air Defense Artillery Brigade.

(3) Commander, 10th Support Group. (IAW Department of the Army, General Order #16, dated 20 December 2002, 10th SG remains the GCMCA of Army elements assigned to Okinawa. USARJ will remain as the superior GCMCA.

(4) Commander, United States Army Medical Activity – Japan

4. Any unit or Soldier in Mainland Japan not otherwise accounted for in this memorandum will be aligned for the exercise of military justice as follows:

SPCMCA: Commander, US Army Garrison Japan.

SCMCA: Commander, United States Army Aviation Battalion.

Company Grade Authority: Commander, HHC, US Army Japan.

5. Effective this date, the units are aligned as follows:

a. Commander, United States Army Garrison Japan (USAG-J) is authorized to exercise Special Court-Martial jurisdiction over the following units and commanders:

(1) Commander, United States Army Japan Aviation Battalion – Japan (SCMCA).

(2) Commander, 311th Military Intelligence Battalion (SCMCA).

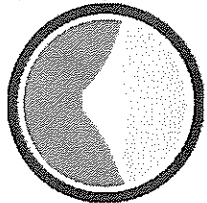

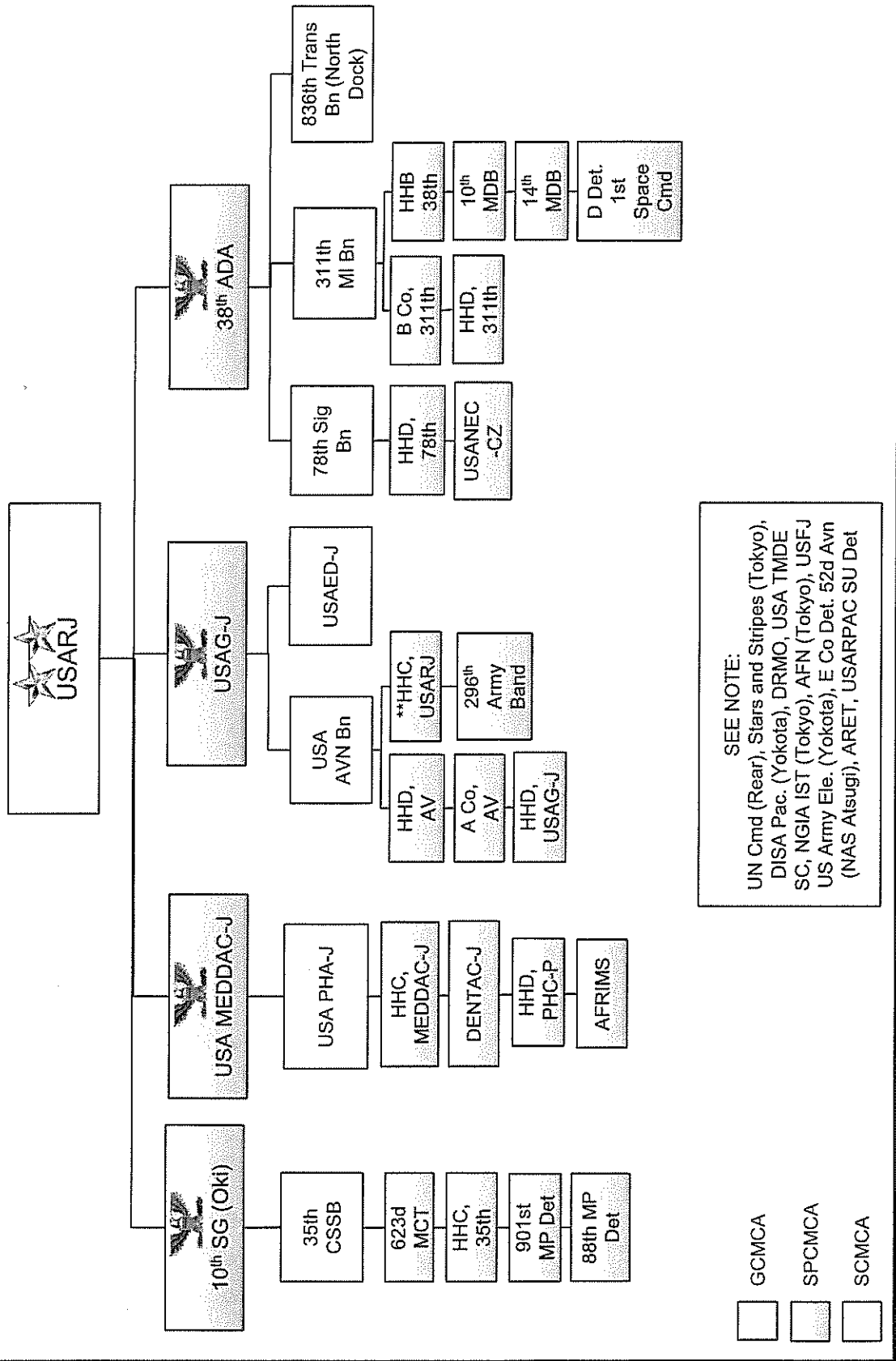
