Due to COVID-19 policies, SOFA personnel arriving in Japan are subject to rules that may differ from rules for other travelers. The rules and policies are complex. This handbook will answer many of the questions you may have regarding RoM.

VACCINATION BASED ROM GUIDANCE



FULLY VACCINATED w/BOOSTER (Up-to-date)

No ROM required but here are important details to be aware of:

O Definition of “Up to Date”: Per CDC guidelines, need to have either 1) received a COVID-19 booster shot; or 2) have concluded their initial vaccination series within the preceding six (6) months (Pfizer and Moderna) or preceding two (2) months (Johnson & Johnson). Children who are not eligible for vaccination or boosters can assume the vaccination status of their parents for the purpose of this RoM policy.

O SOFA status personnel arriving in Japan from another country will not incur ROM if they are up-to-date with vaccinations, per the above definition, and have received a negative arrival test. An international entry test at a commercial airport will meet this requirement. Regardless of vaccination status, travelers are exempt from arrival testing ONLY if their pre-travel test was conducted using a molecular testing method such as RT-PCR, LAMP, TMA, NEAR and produced a negative result. Arrival testing is still required if the pre-travel test was antigen.

O Up-to-date SOFA personnel bound for other bases such as Torii Station, Kure, KCS, and SCS (PCS-in / TDY-in / LV Return, TDY Return) who have a negative COVID-19 test result from the arrival airport OR have a negative pre-travel test result using a molecular testing method as described above can proceed via public transportation (commercial airline, bus, train, taxi) to their ultimate destination.

Note: Unvaccinated / unboosted children, if not eligible for vaccination or booster, can assume the vaccination status of their parents for the purpose of this RoM policy.



VACCINATION BASED ROM GUIDANCE



FULLY VACCINATED w/o BOOSTER (Not Up-to-date)

On Installation ROM for 7 days

Note: Regardless of vaccination status, travelers are exempt from ROM and arrival testing if their pre-travel test was conducted using a molecular testing method such as RT-PCR, LAMP, TMA, NEAR and produced a negative result. An Antigen test does NOT satisfy this condition. Those who are not otherwise exempt will adhere to the procedures in this section.

O Shall travel directly to their coordinated RoM location until receipt of the arrival COVID-19 test. After receipt of the arrival COVID-19 test, traveler is restricted to on-installation RoM until day **seven (7)/168 hours**.

O Public transportation is authorized with a negative arrival test result within the first 24 hours after arrival to allow travelers to arrive at their domicile. This includes commercial air travel within Japan. Strict COVID mitigation measures must be followed to include mask wear. After arrival to their final destination, public transportation is not authorized during the ROM period.

O **Asymptomatic Individuals** may exit ROM without a viral test after day 7 of ROM. MEDDAC-J will not provide notice or clearance.

O **Option:** On or after day 3 of ROM individuals may take a viral COVID test and if the result is negative they may end ROM after day 3.

O During the ROM period, fully-vaccinated individuals may have access to all on-installation facilities while maintaining strict COVID mitigation procedures.

Note: Unvaccinated / unboosted children, if not eligible for vaccination or booster, can assume the vaccination status of their parents for the purpose of this RoM policy.



VACCINATION BASED ROM GUIDANCE



NOT FULLY VACCINATED

In Home ROM for 7 Days

Note: Regardless of vaccination status, travelers are exempt from ROM and arrival testing if their pre-travel test was conducted using a molecular testing method such as RT-PCR, LAMP, TMA, NEAR and produced a negative result. An Antigen test does NOT satisfy this condition. Those who are not otherwise exempt will adhere to the procedures in this section.

O Shall travel directly to their coordinated RoM location until receipt of the arrival COVID-19 test. After receipt of the arrival COVID-19 test, traveler is restricted to in home RoM until day **seven (7)/168 hours**.

O Public transportation is authorized with a negative arrival test result within the first 24 hours after arrival to allow travelers to arrive at their domicile. This includes commercial air travel within Japan. Strict COVID mitigation measures must be followed to include mask wear. After arrival to their final destination, public transportation is not authorized during the ROM period.

O **Asymptomatic Individuals** may exit ROM without a viral test after day 7 of ROM. MEDDAC-J will not provide notice or clearance.

O **Option:** On or after day 3 of ROM individuals may take a viral COVID test and if the result is negative they may end ROM after day 3.

* **Note:** Unvaccinated / unboosted children, if not eligible for vaccination or booster, can assume the vaccination status of their parents for the purpose of this RoM policy.

- Fever
- Chills
- Muscle ache
- Headache
- Diarrhea
- Sore throat
- Loss of taste/smell
- Cough
- Difficulty breathing
- Vomiting

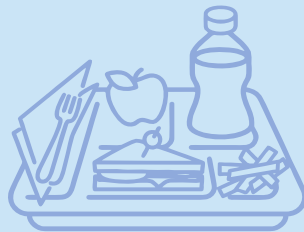

RECREATION, LAUNDRY, SMOKING



Outdoor Recreation for All Personnel in RoM

Unit Barracks and Unaccompanied Housing

- Must have **negative COVID test** result from airport.
- Non vaccinated: only available during the **2000-0400** time window and must be actively engaged in recreation.
- Fully vaccinated: No time or location restrictions for fully vaccinated.
- Maintain social distancing at all times.

Camp Zama Lodge and Hardy Barracks

- Must have **negative COVID test** result from Airport.
- Non vaccinated: only available during the **2200-2400** time window and must be actively engaged in recreation.
- Fully vaccinated: No time or location restrictions for fully vaccinated.
- Maintain social distancing at all times.

Army Family Housing

Must have **negative COVID test** result from airport.

Non vaccinated: Outdoor recreation from **2000-0400**.

Fully vaccinated: No time or location restrictions for outdoor recreation.

Off Base Residence:

If not vaccinated, outdoor recreation and activities are limited to your porch, balcony, or residential property boundaries.

Laundry:

Consult your unit leadership, building CQ, or the lodging staff for the laundry policy applicable to your building. Laundry is not available to RoM guests in some buildings. **Non-vaccinated personnel are not authorized to leave your building location for laundry.**

Smoking:

If non-vaccinated, you may use your recreation period to smoke. You must use the designated smoking area of your building. You must maintain social distancing and, as a courtesy, please inform others that may be present in the smoking area of your RoM status.

- Wear a mask while inside your building and while transiting to/from the recreation route or smoking area.
- Maintain social distancing at all times.
- Practice hand hygiene before and after recreation activities.



PET PROCEDURES



For the Camp Zama Army Lodge, incoming pets will reside in RoM areas with their families with official documents.

(Service dogs ONLY!)

Cats are permitted in pet friendly rooms.

If pet friendly rooms are not available, pets will be boarded at cost at the Camp Zama Kennels (information needs to be provided 30 days prior to arrival).



Dogs: Cost per day

- \$20 per day (One Dog)
- \$25 per day (Two Dogs)
- \$30 per day (Three Dogs)

Cats: Cost per day

- \$13 per day (One cat)
- \$20 per day (Two cats)

Fully vaccinated pet owners may walk their pets as required after receiving negative arrival test results.

If not fully vaccinated or if not yet in receipt of negative arrival test results, the pet owner may use their recreation time, as described on page 7, to walk their pet. During other times the pet owner needs to ask for assistance from their sponsor.

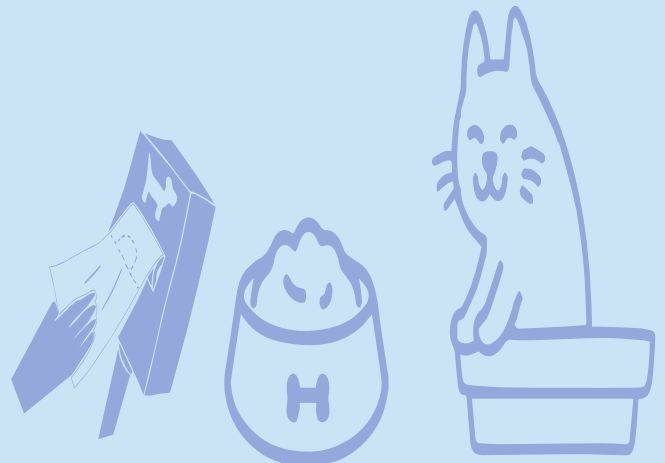
All pets must be registered with the installation Veterinary Treatment Facility (VTF) by phone upon arrival to Camp Zama.

All pets are required to report to the VTF within 72 hours of the owner completing RoM for an import rabies quarantine exam, or to be released from Government of Japan Rabies Quarantine if applicable.



Owners are responsible for providing all pet supplies (food, cat litter / pet waste bags, etc.) and any additional sanitation supplies for the room.

Please provide all immunization and kennel boarding documentation to the pet kennel on arrival.
